Title: Treatment Guideline for Aesthetic Soft and Hard Tissue Results

Level: Advanced

Abstract

Today surgical techniques for soft and hard tissue defects are well-known and well-documented. However, each case is still unique and requires individual planning to achieve the best clinical outcome.

Careful case evaluation in consideration with patient expectations and selection of the appropriate surgical and restorative techniques are key elements to define the treatment plan with long term clinical outcome and evidence.

For example immediate Implant placement with the Trabecular Metal™ Implant in the aesthetic zone shows excellent outcome, with the stability of soft and hard peri-implant tissues in a five year follow up study, published recently. If single stage implant placement is not given, bone grafting solutions will be introduced to rebuild the necessary bone quantity.

The Zimmer Biomet Institut SimLab allows clinicians to practice real-life case scenarios, in their entirety, on one-of-a-kind, proprietary simulation patients.

Course Objectives

This two day interactive course aims to guide attendees through patient cases suffering from different hard and soft tissue defects.

After case evaluation including digital imaging and defining the end result attendees have the opportunity to work with a variety of most modern materials, techniques and instruments to gain the results.

Especially flap designs, elevation, passivation, repositioning and suturing techniques are crucial for high aesthetic outcome. Moreover customized bone blocks or reinforced membranes will be introduced as valuable options for state of the art hard tissue reconstruction.

With the treatment of soft and hard tissue management the backward planning principle will be completed.
