

# Treatment Guidelines for Immediate Placement & Immediate Restoration in the Aesthetic Zone



## REGIONAL PROGRAM

### PROGRAM DESCRIPTION:

This program will provide attendees with a strong theoretical basis on the management of single-tooth implants in the aesthetic zone. A secondary objective will be to maximize peri-implant soft-tissue aesthetics around definitive restorations – critical elements for achieving sustainable aesthetics.

### PROGRAM OBJECTIVES:

At the completion of the program, participants should be able to:

- Distinguish preoperatively between high, medium and low aesthetically demanding conditions (e.g. lip line, smile design, etc.).
- Review clinical and radiographic data prior to treatment planning this type of restoration.
- Converse with surgeons and dental lab technicians regarding the specifics of immediate implant placement and restoration.
- Identify and order the requisite components to accomplish this type of treatment.
- Be familiar with different methods of fabricating immediate single-unit non-occlusally loaded restorations.

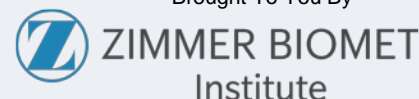
